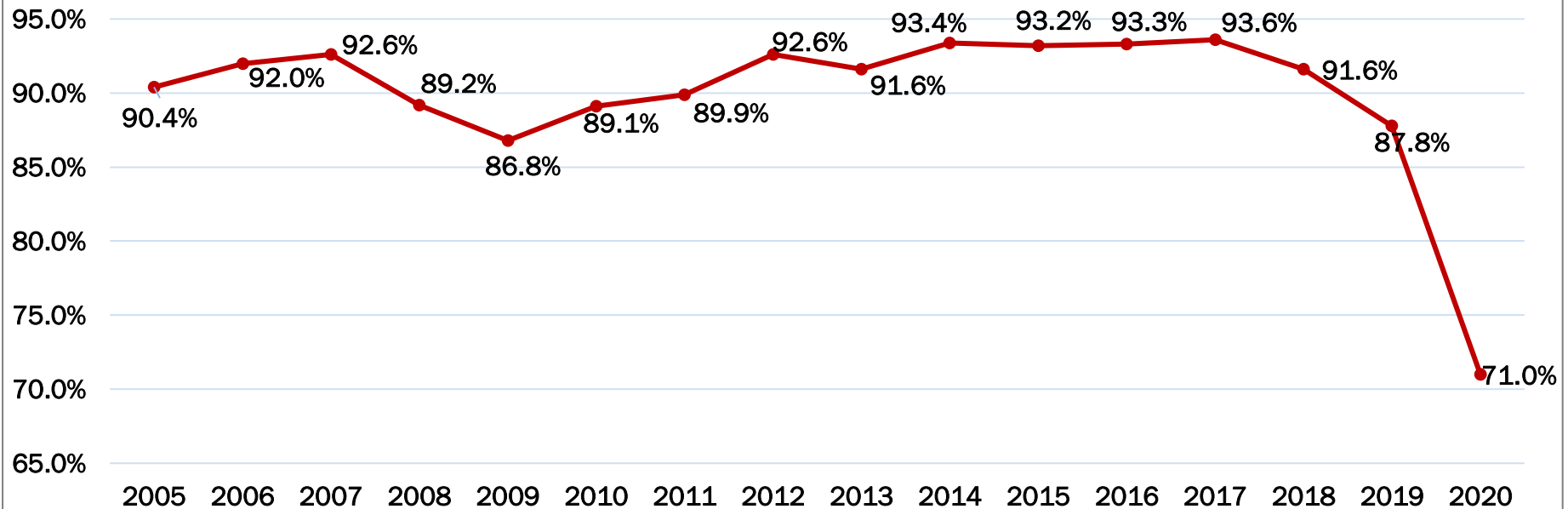

# Jurisdictional Apportionments – Episcopal Fund

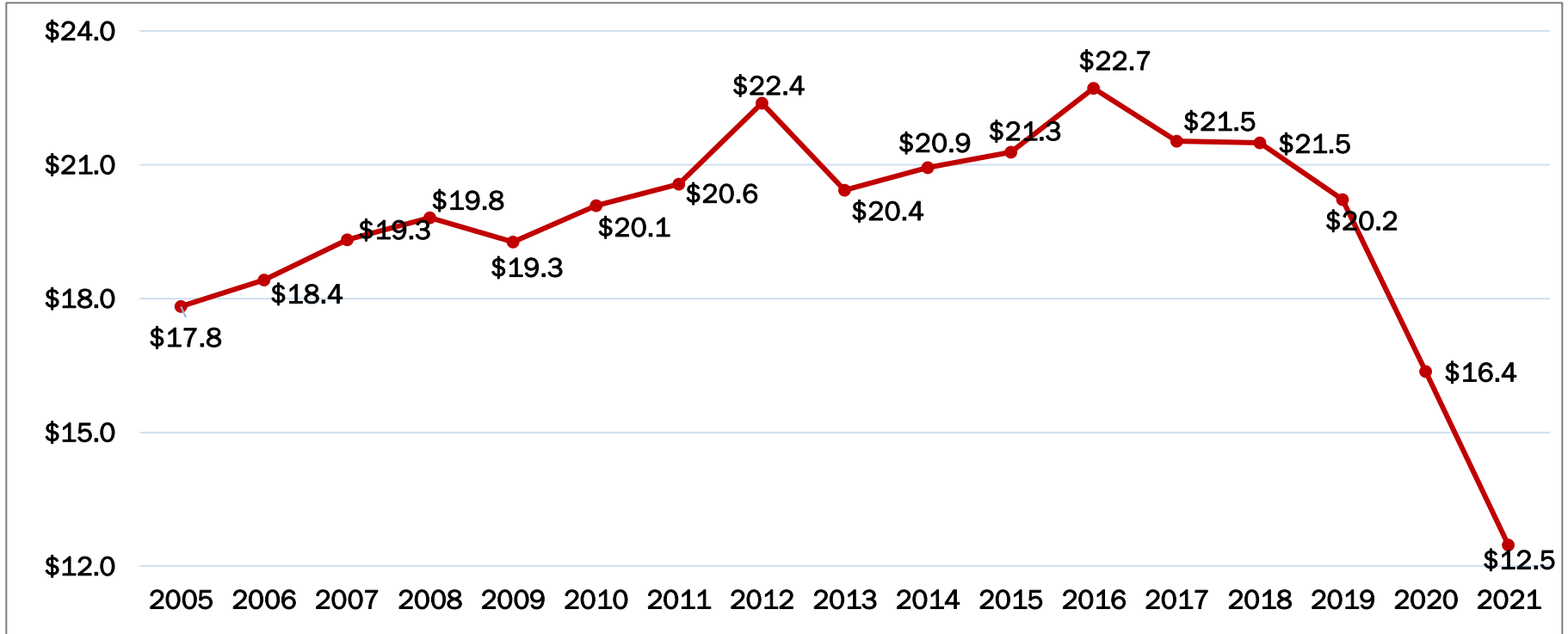
## Episcopal Fund Collection Rate Trends



2020 Projection is based upon year-to-date June in relation to the average of the same period in 2017 and 2018. This was used instead of 2019 as many conferences and churches temporarily withheld funds after the 2019 General Conference.

2020 Projection as of June 2020 is 66.1% vs. 65.6% as of May 2020.

# Episcopal Fund Collection Trend in Millions of \$

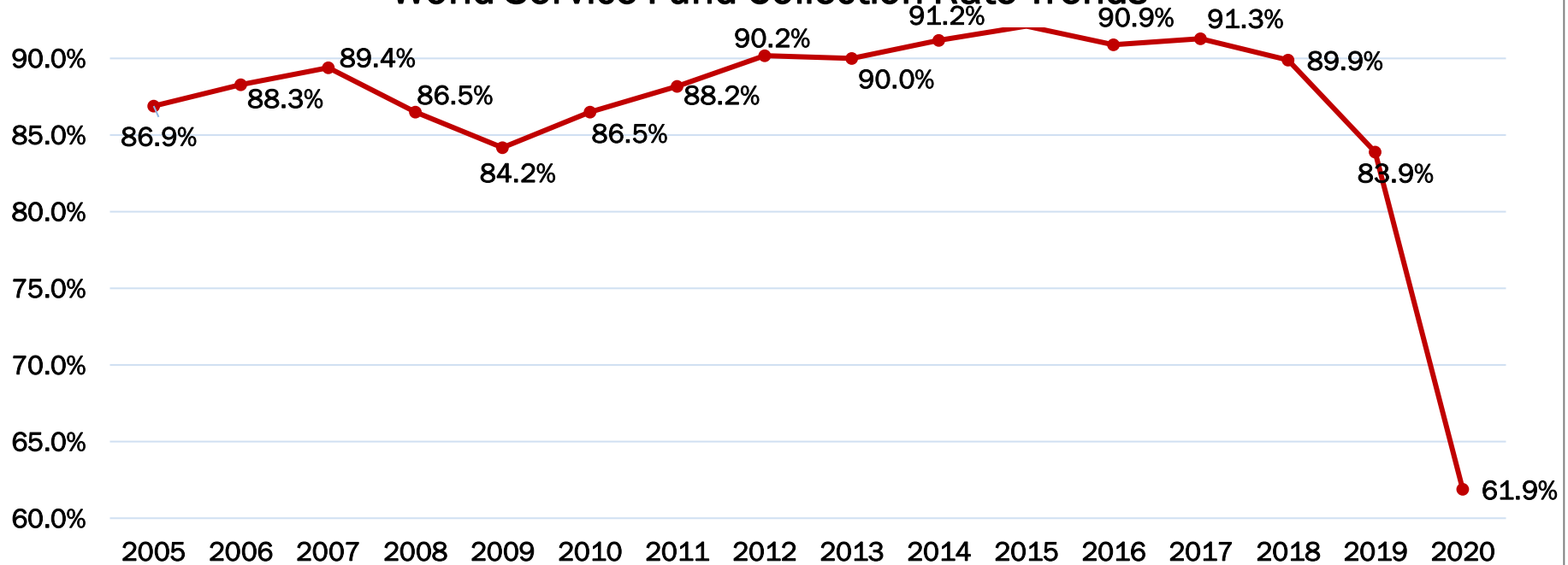


2020 is a projection based upon the seasonal trends and collections in 2017 and 2018

# Jurisdictional Apportionments – World Service Fund

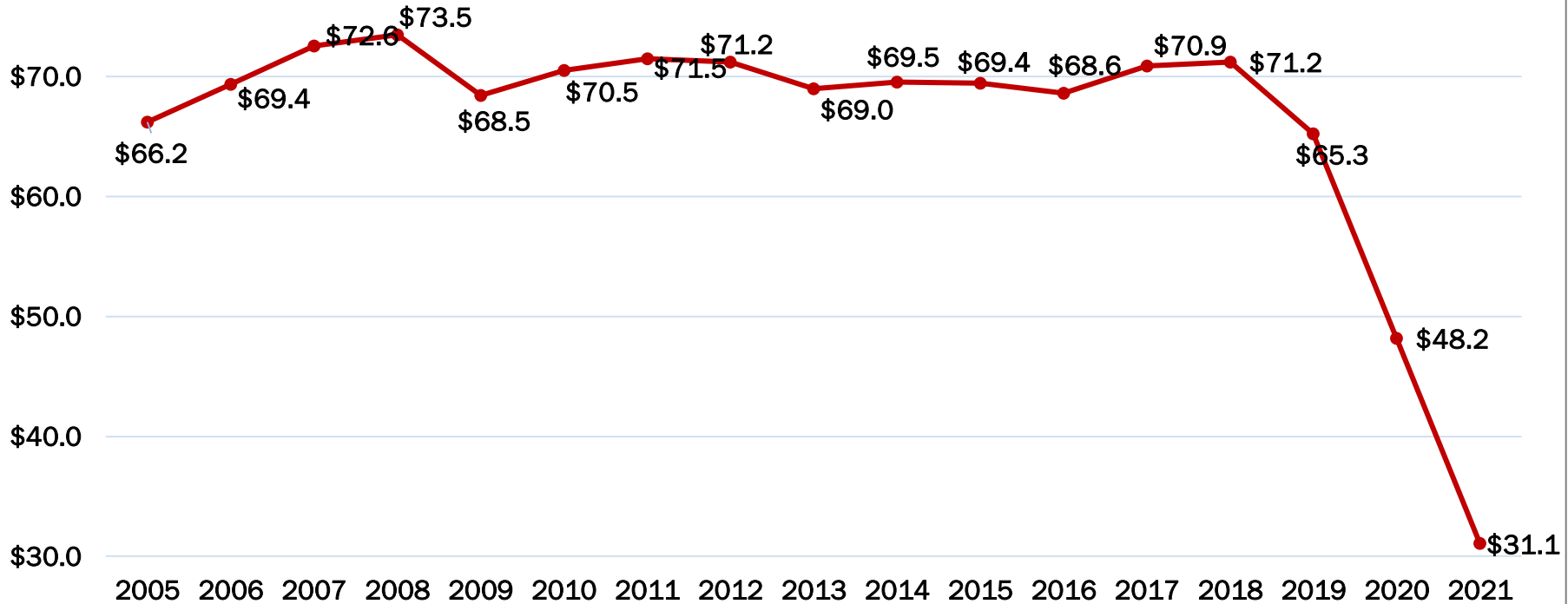
## World Service Fund Collection Rate Trends

# World Service Fund Collection Trend in Millions of \$



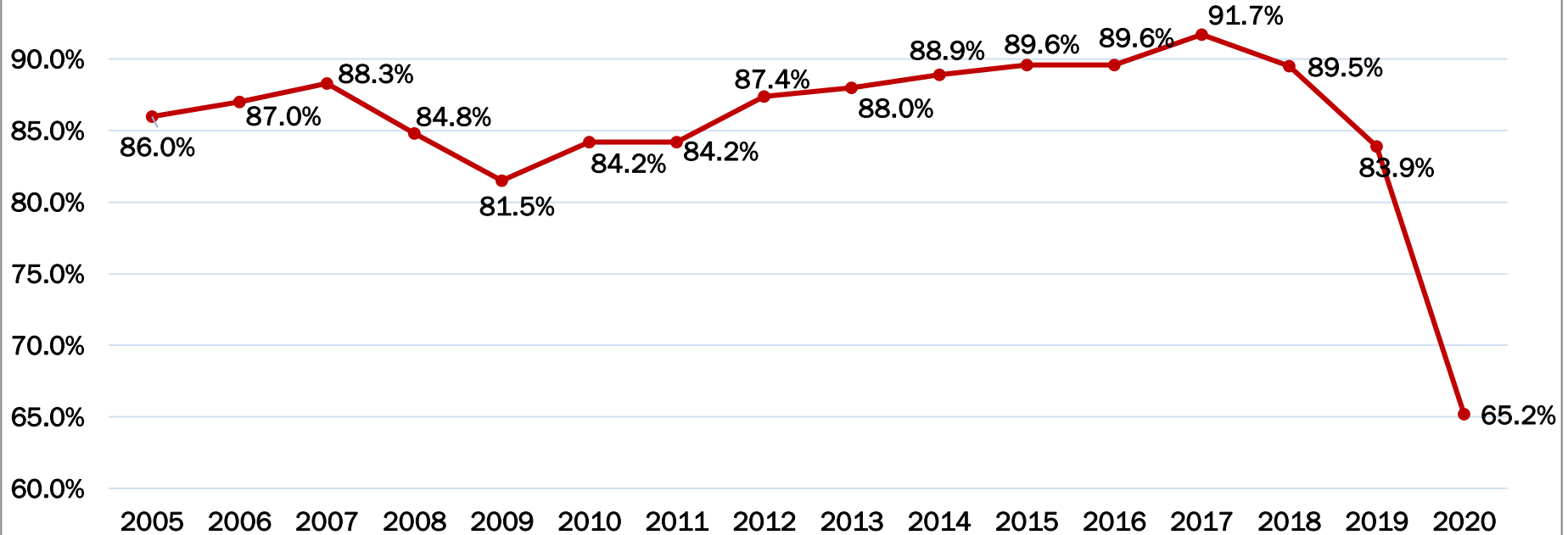
2020 is a projection based upon the seasonal trends and collections in 2017 and 2018

# Jurisdictional Apportionments – General Administration Fund

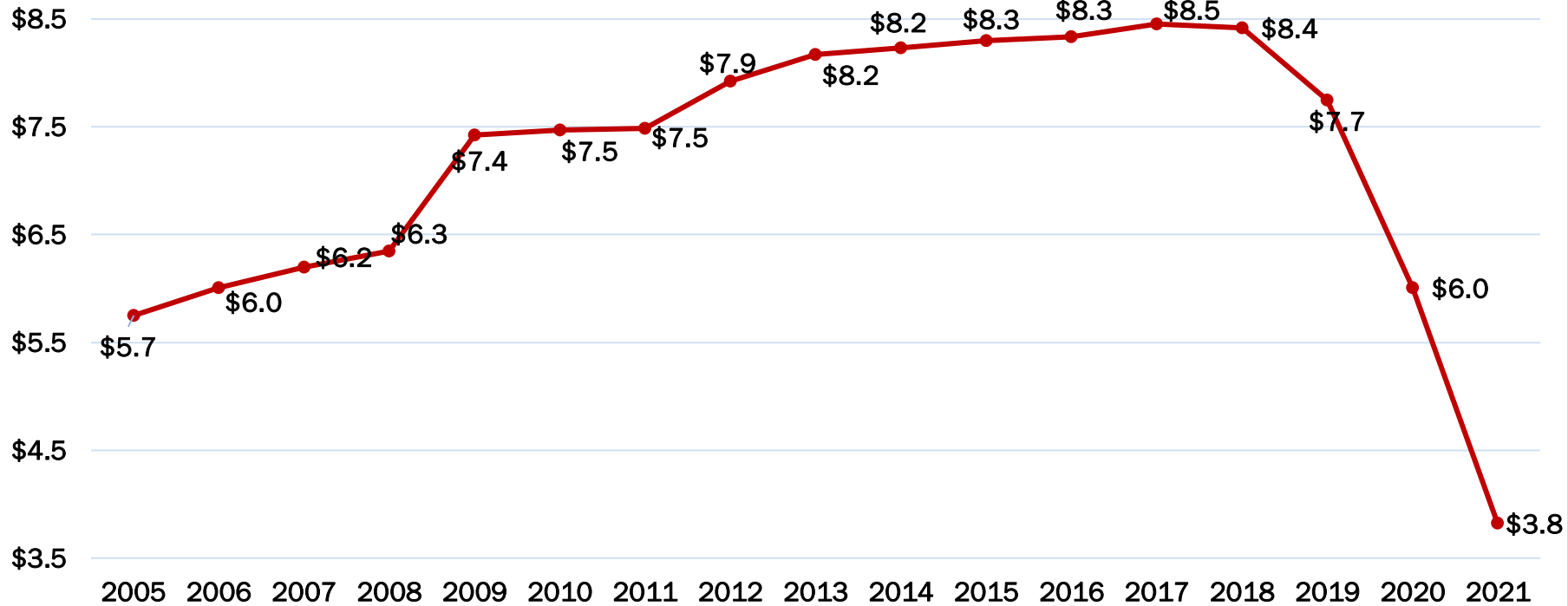
## General Administration Fund Collection Rate Trends
